- A non-refundable deposit of \$100.00 is due to fully confirm your party.
- Dinner & Dancing Parties require an additional \$100.00 deposit.
- Party **must** end at the scheduled time, which includes all attendants and all personal party items. There will be a \$25.00 fee for each additional 15 minutes past your scheduled time.
- You may arrive no more than 20 minutes prior to your party to set up.
- Pack up will begin 15 minutes before the end of your party slot.

Terms & Conditions

Party Terms and Conditions (Known throughout these terms: We / Us = Delaware Dance Parties LLC, You = Party Host, individual booking and paying for a Party)

1. To confirm your Party Date & Time a non-refundable deposit of \$100 must be made at the time of booking. In addition, any food or other inclusions (where applicable) require an additional deposit. Payment can be made by CC via PayPal and or in Cash at the studio when available. Your final Payment can be made via Cash or by CC at your Party.
2. The maximum number of children permitted is 36. Children include ages 2-17. Any children under the age of 2 do not count towards the number of children. ALL infant, babies and toddlers, in attendance, MUST be supervised at ALL times and not be allowed on the floor where attendants are dancing or allowed to roam around without an adult in **direct** contact. Parents and Party Host assume all responsibility for the children.
3. The allowed number of children per party is set, food is provided for that number of children (where applicable). If you are adding additional food for adults you need to confirm the number adults no later than 48 hours prior to ensure an appropriate order can be placed. Your food order remains the same for the maximum number of children included. If fewer children attend the order can replace the need to purchase additional food for adults. This is your responsibility via your RSVPs.
4. You will receive a booking confirmation the day you book in the calendar. Your party is not Confirmed until deposit has been paid
5. We reserve the right to refuse any Party request or to cancel a booking for reasons that are out of our control (e.g. unforeseen facility closures). We will not incur any liability from refusal or cancellation. In this instance only any payment made towards your party will be refunded in full.
6. Cancellations must be received no later than 7 days prior to the party date. If cancellation is made properly you can reschedule the Party at no additional deposit or fee. If cancellation is made after 7 days of the Party Date an additional \$50 fee will be added to the rescheduled Party. If canceled within 24 hours a \$75 fee will be added to the rescheduled Party. All Parties to be rescheduled must be held within 60 days of initial booking. If canceled with no notice whatsoever you have forfeited your deposit and must pay another deposit when re scheduling. All Deposits are non-refundable; the additional fee for cancellations is added to the actual party fee and is not part of the deposit. (24 hour or no notice cancellations involving Medical Emergencies can appeal the additional fee by providing a medical document.)
7. The Party Host shall ensure that all those attending, adults and children comply with the standard code of conduct, rules and safety regulations. The Host accepts **full responsibility** for all those attending the party. We will not incur any liability for non-compliance. We reserve the right to remove any individual from the facility that does not comply with our terms and safety, to ensure the enjoyment and safety of others.
8. **Included** food, drink, tableware and gift items (where applicable) will be set up by us prior to your time slot. Included items are for the children only. Any items provided by you can be brought in **no earlier** than 20 minutes prior to Party time slot and we will assist you in setting up. Hosts providing their own food can have it delivered at any time during their Party if desired but no later than half way through.
9. Absolutely **NO** alcoholic beverages are permitted. Only non-staining drinks are allowed. If cutting cake **ONLY** a knife/spatula designed for this purpose is permitted, **no** sharp knives. **NO** glass. **NO** candy unless otherwise discussed.
10. Parents / Guardians must inform us of any children attending with food allergies no less than 7 days in advance of the party if food is included in your Party Package. If you are supplying food it is entirely your responsibility to know of any allergies of your guests.
11. Attendees must bring in the signed waiver or fill one out when entering the facility. There are no exceptions to this rule. No waiver no admittance!
12. The required adult:child ratio is 1/ 4 under the age of 10 and 1/1 for 2 years and under. This required to ensure the safety of the children and will be enforced.
13. All Waivers include a photo/video release and is required for admittance.

Safety, General Rules and Regulations

The Party Host and Attending Parents are fully responsible for the safety and actions of themselves and the children.

Children:

- BULLYING WILL NOT BE TOLERATED.
- NO Pushing or shoving.
- NO flips, kicks, cartwheels or anything else that involves feet flying wildly through the air.
- NO fast spinning while holding a friends hands
- NO sitting down in the middle of the dancers
- NO running through the dancers
- NO touching of any equipment you may be able to reach
- NO throwing or spinning of anything
- NO standing on chairs or tables
- ALL food and drinks must stay at the tables

General

- Parents please understand that any bullying will not be tolerated; anyone participating in this will be required to leave the facility immediately.
- Adult:Child Ratio is 1/4 for ages 2-10. And 1/1 for any child under the age of two. Adults = 18 and over
- Please dress them comfortably and be prepared for them to get hot.
- You are permitted to give the children items such as glow necklaces, bracelets, rings & tattoos during the party. NO items they can spin or swing around & nothing they can shoot or throw. NO Balls!
- Any adult that is dancing with the children may **NOT** wear any type of sharp heels this is very dangerous for little feet!
- Do **NOT** allow any child under the age of two to be on the floor where attendants are dancing or allow them to roam without direct contact of an adult.
- Parents if dancing with your children PLEASE do not do anything with your child that may injure another child, flipping them, swinging them around and so on.
- ALL food and drinks must remain at the tables.
- NO food anywhere other than the party room.
- NO CANDY or GUM!
- NO GLASS anything!
- You are completely responsible for knowing any allergies of your guests.
- Children are not permitted to go outside of the main studio door without an adult.
- Parents are not permitted to leave without providing an emergency contact number.
- NO smoking anywhere near the main entrance of the building.

BE ADVISED!

We are using flashing and spinning lights if your child has epilepsy or any other propensity towards seizures they should NOT attend a Party, please consult your Physician for more information.
